Coalition Updates

EOHHS Specialty Pharmacy: The Coalition submitted a letter to EOHHS acknowledging concern with Specialty Pharmacy requirements for HCV meds in some MassHealth MCO policies. This policy creates barriers for the homeless in accessing medication. *Letter available on our website.*

Division of Insurance--Sensitive Health Services: The Coalition advocated for Hepatitis C treatment to be included as a sensitive health service, and therefore masked on a policy's summary of payment. Recommendation has been accepted and is pending Commissioner approval.

World Hepatitis Day Call To Action: A legislative call to action took place on July 28. Coalition members and supporters contacted legislators to advocate for a legislative override of Governor Baker's proposed cuts to the HIV/HCV line item (4512-0013). This is ongoing, please continue to contact legislators.

Train the Trainer 9/21: In partnership with HCV Advocate, we hosted a general Hepatitis C train the trainer event at Baystate Health in Springfield, MA. 43 people were trained in HCV transmission, prevention, disease management, and treatment at this event.

Ongoing Efforts:

HCV Provider Database: We are developing a resource of providers throughout Massachusetts offering low-barrier, stigma-free Hepatitis C treatment to those actively using or in treatment. Hep C Treatment Access in the MA Prison System

A discussion on the status of Fowler v. Turco (DOC and Massachusetts Partnership for Correctional Healthcare, and the access to DAA therapies in the MA prison system.

- As of 3/10/15 MCPH treated 31 inmates since the inception of their contract; 2% of the known HCV+ population in MA prisons.
- Liver biopsy still a required HCV treatment staging test in most cases, despite availability of non-invasive and more accurate diagnostic tools.
- Treatment consideration only occurs after 12 months of incarceration, and if there are 12 months remaining in sentence

Proposed Recommendations for Adoption of National Academies Elimination Strategy

- Stipulate that all BSAS funded residential treatment programs incorporate testing, education, and treatment referral as a part of SUD care.
- Look into payer issue for PCP consult of HCV care → HCV consult not billable for PCPs
- Propose one-time, state-wide HCV screening of all adults irrespective of risk
